- I accept that FFYT is not responsible for, nor will I attempt to hold it liable for, any injury, damage or loss I may suffer on account of any conditions, actions or omissions that are beyond its reasonable control. Excepting only liability that directly arises from the gross negligence or willful misconduct of FFYT, I will not hold it responsible for any injury, damage or loss I may suffer while on any third party provided or operated excursion or activity.
- I will review my travel documents for accuracy upon receipt and understand that I may contact FFYT if I have any questions. I understand that it is my responsibility to review the accuracy of all details in the travel quotations provided to me and to confirm the same to FFYT.
